### INVESTMENT OBJECTIVE

To provide strong long-term capital growth to investors and target returns in excess of CPI+5% over rolling 10-year periods. This fund is primarily invested in global equity assets while the return and risk profile is expected to broadly reflect that of global equity markets.

- Governed by the Collective Investment Schemes Control Act (CISCA) and prudent investment management principles apply.

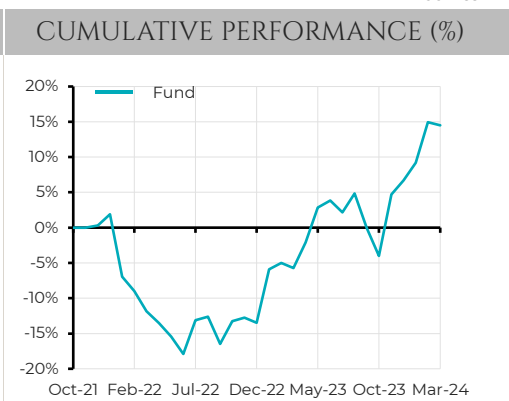
### RISK INDICATOR AND WHO SHOULD INVEST

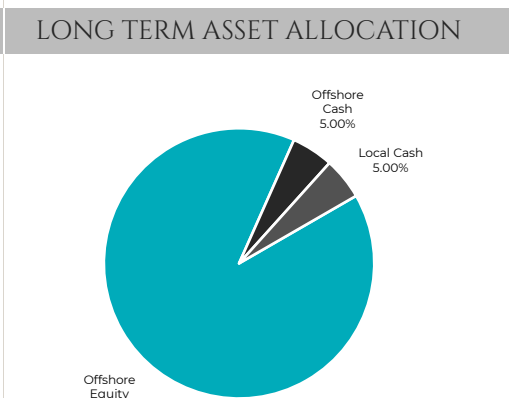
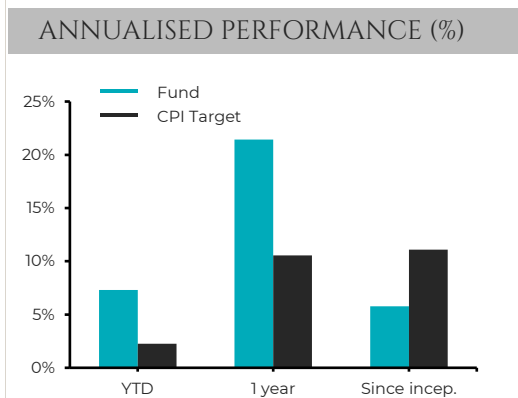

## FUND COMMENTARY

The Worldwide Fund delivered positive returns of more than 7% over Q1 2024. The Fund's global equity exposure has been incrementally increased over the past 9 months and the profile of the Fund skewed towards a global equity fund. In future, it will reflect the return and risk dynamics of global equity markets with marginal exposure to South Africa.

It is a well-diversified equity fund with large exposure to US markets, all global regions and other major countries. Our investments in the Old Mutual Global Equity fund and the 10X Total World Stock Feeder fund added value, while the Stonehage Fleming Global Best Ideas fund and Ninety One Global Franchise fund experienced a difficult quarter.

The global economy remains resilient with projected real GDP growth in the US of 2.1%. The market envisioned a soft-landing scenario in the US, which drove equity markets higher. The MSCI World index was up almost 9% in USD, mainly driven by technology stocks in the USA while developing countries added only 2.4% growth.

## GLOSSARY

**Annualised Performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Total Expense Ratio (TER%):** The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

**Transaction Costs (TC%):** The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

**Total Investment Charges TIC (%) = TER (%) + TC (%):** The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
